- 1) Flight lab fees are in addition to tuition and university fees.
- 2) Flight includes aircraft rental charge plus instructor charge on dual flights.
- 3) All times are based upon FAA required times as specified in our Training Course Outline.
- 4) Students that do not complete all lab lessons within the mandatory hours must still complete those lessons prior to progressing to the next flight lab.
 Flight and ground fees will be charged to the student on a per-hour basis to complete any lab lessons not completed during the mandatory flight hours.
- 5) Ground instruction assumes an average of 0.5 hours ground given on each dual and sim flight plus 1.0 hour for each ground lesson, unless the ground time is otherwise specified. Actual times may vary.
- 6) A fuel surcharge may be implemented if necessary to compensate for market fluctuations.
- 7) All prices are as of 1-Jan-24 and are subject to change.
- 8) A Practical Exam ("checkride") must be scheduled with an FAA Designated Pilot Examiner (DPE) after completion of Private Pilot Certification lab, Com/Instrument labs IV and V, ME lab, CFI lab, CFII lab, and MEI lab. The fee for each FAA Practical Exam is set by the DPE who administers the check ride, and will be paid by the applicant student directly to the DPE. Henderson Aviation will charge the student's account for rental of the aircraft flown.
