September 10, 2021 minutes were approved.

President's Report:

Dr. Welch offered condolences to Shane Broadway on the passing of his mother. He offered concern for Chancellor West's mother who is ill. There was a moment of silence.

He announced that Kelly Damphouse was named to the NCAA Board of Directors.

COVID – He expressed that we were hopeful and that things were better but to watch the Omicron variant. He said it may be a different kind of spring.

He mentioned that the system was going to be more collaborative and share more services which is more strategic. He talked of the HSU human resources and payroll moving to a system management model. He said that HSU will compensate the system but there will still be a net savings. He said that the payroll employees were re-assigned to open positions.

Chancellor's Report:
