* Resolution from the Faculty Senate

WHEREAS, Interim President Bobby Jones stated to the Faculty Senate president that his number one priority is salary increases for non-classified employees; and

WHEREAS, Mr. Jones' goal is to give non-classified personnel some type of salary increase during the spring 2012 semester; and

WHEREAS, Mr. Jones mentioned that Arkansas is currently ranked 50th (dead last) in the Southern Regional Education Board (SREB) for non-classified employee salaries; and

WHEREAS, Mr. Jones mentioned a salary increase between 2-3%; and

WHEREAS, Mr. Jones stated that he realized that if we do not do something quickly and over the long-term that Henderson will continue to lose good faculty; and

WHEREAS, he also acknowledged that we are far behind in salary rates and that both an immediate and long-term plan must be implemented in order to remedy this problem; and

WHEREAS, the faculty have not received a consistent cost of living adjustment (COLA) for more than a decade; therefore be it

RESOLVED, that the Henderson State University Faculty Senate strongly encourages the university to implement an annual cost of living adjustment (COLA) for non-classified employees equal to the previous year's rate of inflation, beginning in the spring semester of 2012; and be it further

RESOLVED, that the Henderson State University Faculty Senate strongly encourages the university to implement an 8% salary increase for 9 and 12 month faculty for the 2012-13 budget; and be it further

RESOLVED, that the faculty and non-classified salaries be a high priority of the incoming University president; and be it further

RESOLVED, that the Henderson State University Faculty Senate look forward to the recommendations of the compensation committee for the 2013-2014 budget.
