- Operations and Handbook Committee:

- Buildings and Grounds Committee:
 - New description of this committee's responsibilities proposed updated on the Senate website, to be in agreement with the description in the Senate Constitution.  Laird (Chair of the Person of Concern Committee). They reported back to Dr. Givan that the
 situation of lack of confidentiality should not have happened, has been addressed, and
 should not happen again. They requested that any future concerns are to be brought to Dr.
 Patterson's attention.

New Business

- Discussion of need for an election for a replacement of the Senate Secretary position.
- Discussion of need for an election for Webmaster-Elect position.
- Election for both positions will be held in the fall.
- Regarding timing of this year's course evaluations was discussed by Ms. Jennifer Holbrook.
 Initially, the end date for evaluations to be submitted extended beyond finals. There was a miscommunication regarding timing, and evaluations were closed as soon as that was discovered. The situation should not arise again.
