# **President's Report**

Borsig meeting was brief. Discussed progress on financial front and progress with Banner implementation. Thanked him for stepping in.

# Meeting with Hunt

There was a discussion on retrenchment. The week of 11-8 Huron Consulting will have campus meetings. They will look at the prior Academic Review. Identify needed data. Decide which programs need review. Then procedures will follow the financial exigence polices in the Handbook.

International students are no longer living in the International house. Now Greek leadership is located there. Asked how that occurred. Response was that the house was not suitable for living under housing code. It can be used for meetings not residence. International students still have space set aside for meeting and fellowship. Hunt said if anyone feels international students are being impacted academically by the change they should schedule an appointment with him to discuss it.

Dr. Givan received email regarding Bobbie Lee being made responsible for Title IX, Title VII, and student judicials, staff relations and Ethics Point. Her new title is Director of Compliance. Staff inquiries included questions about conflict of interest, too many eggs in one basket, Title VII is generally an HR issue, is she qualified?

Dr. Hunt responded that he will ask questions and report back.
